Ecosystems and the 2030 Agenda: Examining the challenges and opportunities for effective co-implementation

The contribution of biodiversity and ecosystem services, and the Aichi Biodiversity Targets, towards the achievement of some or all of the Sustainable Development Goals (SDGs) has been demonstrated by a number of recent review. Actions to achieve the Aichi Biodiversity Targets, such as raising awareness about the diverse benefits we obtain from nature, and the importance of the sustainable use of ecosystems and biodiversity, are essential to achieving the 2030 Agenda. In addition, a recent focus through the CBD on strategic actions for mainstreaming biodiversity within and across sectors also supports the 2030 Agenda.

While the proposed process for the preparations of the post-2020 global biodiversity framework includes <u>a series of regional consultations</u>, and a number of agencies are reviewing the thematic linkages between the Strategic Plan for Biodiversity 2011-2020 and the SDGs, one of the apparent gaps remains in examining how the framework can help to overcome the challenges in effectively implementing such cross-sectoral mainstreaming.

This side event will gather experts and practitioners to consider:

- Have existing policies/structures helped or hindered the implementation of the Strategic Plan through enhancing linkages with sustainable development?
- How could the post-2020 global biodiversity framework positively support this?
- What is needed to achieve this (e.g. capacity support, further research, better M&E systems, increased communication and awareness)?
- What does this mean for post-2020 targets, goals, mission and actions?
